Minutes, annual reports (printed) and other records of the Edinburgh and District Trades Council, 1859-1981. It is probable that the Council was formed in 1853, some years before the earliest formal record of its proceedings, making it the oldest existing trades council in Britain after that of Liverpool, and references can be found from 1826 to the activities of earlier *ad hoc* committees of trade union delegates in the city. The main series of minutes of the Council are almost continuous from 1859, forming the earliest full series of trades council records in Scotland.

In the minutes for 1859-60 the Council described itself as 'The United Trades Delegates Association of Edinburgh & Vicinity'; its title was then altered to the 'Council of United Trades Delegates'; after re-organisation in 1867 it became the 'Edinburgh United Trades Council'. From 1888 it was being referred to as the 'Edinburgh and District United Trades Council', amended in the minutes from 1892 to the 'Edinburgh and District United Trades and Labour Council'; by 1912 the current title of the Council was established.

The *Minutes of Edinburgh Trades Council*, 1859-1873, have been edited, with an introductory essay, by Ian MacDougall for the Scottish History Society, Edinburgh, 1968, and there is a centenary essay on the history of the Council by Hamish MacKinven in the *Annual Report*, Edinburgh, 1959 (see no.51, below).

The Trades Council collection includes also a minute book and financial record, 1905-19, of the Scottish Workers' Representation Committee, later the Labour Party, Edinburgh Branch: for other Edinburgh and Leith Independent Labour Party and Labour Party records, see Deps.203 and 306, Acc.4977/16-18, and Acc.5241.

Edinburgh & Leith Municipal Committee

53. The minute book, 14 April 1899 - 6 Feb 1903, of the Edinburgh and Leith Workers' Municipal Committee. The remit of the Committee was to press for and promote working class representation on the public boards of both burghs.

Local Committee

54. Minute book of the Local Committee of the Council, 12 May 1910 - 23 Oct 1915. The Committee was concerned with industrial relations and other more general local issues, eg public health.

Leith Workers' Municipal Committee

55. A copy of the *Third Annual Report and Financial Statement* of this committee for Feb 1902 - Feb 1903, Leith [1903]. This organisation appears to have been constitutionally distinct from the Edinburgh and District Trades Council.

Political Committee

56. Minute book, 21 April 1926 - 7 Nov 1928, of the Political Committee of the Council. The Committee's principal activity appears to have been to liaise with Labour city councillors on matters of mutual interest.

Organising Committee

57. Minute book, 27 Aug 1937 - 3 May 1945 of the Organising Committee of the Council. The Committee's remit was to encourage and facilitate union organisation within workplaces.

Press-Cuttings

58. A volume of press-cuttings, 1914-25, probably assembled by the Secretary of the Council, illustrating the public activities of the Council, and current local and national politics and industrial relations.

Scottish Workers' Representation Committee

- 58-9. The minutes and income & expenditure record, 1905-19, of the Scottish Workers Representation Committee, Edinburgh Branch. Composed of representatives of trade unions and of the Independent Labour Party, it became, in April 1907, the Edinburgh Branch of the Labour Party (Scottish Section), the S.W.R.C. having earlier affiliated to the UK Labour Representation Committee, which had just re-titled itself as "The Labour Party".
