The Scottish Working People's History Trust was established in 1992 on the initiative of the Scottish Labour History Society and has three principle aims:

- ii) To undertake recording of the testimony of working people, to ensure the permanent preservation of these recordings and to publish or broadcast them wherever possible.
- iii) To publish interesting documentary sources on the lives of working people and to promote their use in the broadcast media.
