Some correspondence and papers, 1868-1930, of the Rev. James Calder MacPhail, D.D. (1821-1908, minister of Pilrig Free Church, Edinburgh, and of his son James Robert Nicholson MacPhail, KC (1858-1933), Sheriff of Stirling and historical editor of material relating to the Highlands and Islands.

A native Gaelic speaker born in Lochbroom, Wester Ross, Dr. MacPhail was responsible for the creation of a bursary scheme for the Free Church of Scotland, instituted in 1869, to send Gaelic-speaking boys from areas of the Highlands and Islands, many desiring to study for the ministry of the Church but then without schools able to take them to a level to enable them to enter university, by sending them "to a Grammar School in a University town, that they might there obtain ... a preparation for college". His papers in this collection refer entirely to the operation and administration of this bursary scheme.

Papers relating to the continuation of a MacPhail Bursary scheme, set up posthumously by his family, and other papers, some of the Highland Committee of the United Free Church, are addressed to Sheriff MacPhail or his sister. Papers relating to the Park {Pairc] Deer Raid in Lewis, 1887, a celebrated incident in the land reform campaigns of this period, are those of the raiders' defence solicitors and counsel.

MacPhail, *The Crofters' War*, Stornoway, 1989, pp.202-6; the case, dependent on some participants turning King's Evidence, collapsed and all accused in this case were acquitted.
