## Notes on the Various Accessions of Rutherford and Oliver of Edgerston Papers

The Edgerston Archives, comprising the papers of the Rutherfurds of Edgerston, Frederick Scott Oliver and his wife, Katharine Augusta, the McLaren family, and William and Otilie Wallace, were acquired by the National Library in a number of separate lots in 1980 and 1981. They are as follows:
