Research papers, c. 1989-98, of Gael Turnbull for his biography of John McLeod Campbell.

John McLeod Campbell, 1800-1872, was a Church of Scotland minister and theologian. After an education at Glasgow and Edinburgh universities, in 1825 Campbell was presented by the duke of Argyll to the parish church at Rhu, near Glasgow. Campbell's preaching came under scrutiny as he began to preach that 'assurance is the essence of faith', a view inconsistent with the doctrinal position of the Westminster confession, which ministers of the Church of Scotland were required to observe.

In 1830, a petition by a number of Rhu parishioners charging Campbell with heresy was presented to the presbytery of Dumbarton. Campbell was found guilty by the presbytery in March 1831, a verdict upheld on appeal by the synod of Glasgow and Ayr and finally by the general assembly. After his deposition from the ministry, Campbell spent two years preaching in the western Highlands before returning to Glasgow. There he continued to preach from a small chapel without pay until 1859, when his health forced him to retire from public ministry. Friends with many eminent churchmen of the time, Campbell became one of the leading theologians of the Victorian era.

Gael Turnbull, poet and medical practitioner, took this project up after his retirement from medicine. The papers include research notes for John McLeod Campbell's life, work and family, copies of his letters, and a copy of Turnbull's unpublished biography. The contents of the files have been retained as Gael Turnbull created them, and the files arranged into the series listed below. Multiple drafts of his biography, some of which appeared to be duplicates, have been weeded.
