Thomas Jones

- 1. Attendance certificate, 1786, for Thomas Jones stating that he attended classes on Physick, Materia Medica and Chemistry, signed by George Fordyce, who was at the time physician at St Thomas's Hospital, London.
- 2. Attendance certificate, 1786, for Thomas Jones stating that he attended lectures on Midwifery and the Diseases of Women and Children, given by William Osborn, a lecturer in Midwifery at the College of Physicians, London.

George Sinclair Williamson

- 6. Letter, 1855, of G S Williamson to his nephew Thomas Jones and his wife Carry, from the Crimea, telling them he had been given the title of Nazim Bey by Omar Pasha, for his excellent organization of the Turkish Hospital.
- 7. Letter describing the journey to Sebastopol, and speaking of "this accursed and disastrous expedition".
- 8. Volume containing fifty-one items entitled "Official Documents relating to Colonel Doctor George St Clair Williamson's Services in the Danutian Principalities", arranged by his nephew, Thomas W Jones, WS, 1905.

From the documents, it seems that Dr Williamson on exhibiting his diplomas was granted the necessary licenses to practice in various countries; he settled in Moldavia from 1843-53, principally as doctor for the Gendarmerie in Jassy (now Jasi). He was forced to leave his post because of the enmity of some Government officials, but later managed to return. There are also copies of medical certificates testifying his unfitness to continue in his post on General Cannon's staff in the Crimea, Jan and Feb 1855. He returned to Jassy, and in 1858 was granted an increase in salary as recognition of his services.
